

10 The Court hereby modifies its earlier orders of January 30, 2013 and March 4, 2013.
11 Enterprise is hereby **ORDERED** to provide plaintiffs and the Court with at least 60 days' notice
12 prior to commencing any activity at the Proposed Site that goes beyond the scope of or is
13 inconsistent with the terms of Enterprise's recent Notice of Construction Activity, including any
14 construction activity outside of the outlines of the road to the noticed Class II facility and the
15 parking lot as depicted on the map attached to Enterprise's Notice, any water, sewer or other
16 utility hookups, and any construction of permanent fixtures, structures, or infrastructure.
