1 IT IS HEREBY ORDERED that, good cause having been shown, the Stipulation between  
2 Plaintiffs JEANETTE HOANG, YUN WU, GUANG GU XIANG, MENGTING FANNY KUO,  
3 GIA NHAM THANH, EDMOND CAU VAN, GAO ZHI WEI, DANNY HUNG LEUNG, YE-GUI  
4 BU, and COOC MAN COONG (“Plaintiffs”) and Defendant VINH PHAT SUPERMARKET, INC.  
5 (“Defendant”), for leave to amend Plaintiffs First Amended Complaint is GRANTED pursuant to  
6 Federal Rule of Civil Procedure, Rule 15(a)(2). The Second Amended Complaint attached as  
7 Exhibit A to Plaintiffs’ and Defendant’s Amended Stipulation shall be deemed filed and served as of
