22 Plaintiff United States of America and Defendants Matthew R. Anchordoguy,  
 23 Anchordoguy and Company Limited Partnership, and John R. Barlow stipulate and agree as  
 24 follows:

- 25 1. The current deadline for the parties to file the Joint Status Report, as provided for
- 26 by the Court’s Order of October 8, 2013, is November 22, 2013. See ECF No. 17.
- 27 2. Since establishing this deadline, lead counsel for Defendants, who is handling the
- 28 negotiations of the issues arising in the Joint Status Report, has learned that he is to undergo
