
**ORDER ADOPTING FINDINGS OF FACT AND  
 CONCLUSIONS OF LAW AS TO DR. PAUL  
 HOLMES AND GRANTING PARTIAL  
 JUDGMENT FOR THE UNITED STATES (Fed.  
 R. Civ. P. 52(c))**

1 A bench trial in this Federal Tort Claims Act action began on September 24, 2015. Plaintiffs  
2 Micaela Palacio and I.P. rested on October 5, 2015. After Plaintiffs rested, the United States made an  
3 oral motion for judgment on partial findings on all claims related to Dr. Paul Holmes pursuant to Federal  
4 Rule of Civil Procedure 52(c). The Court heard argument on the motion and orally granted the motion.  
5 The United States filed proposed findings of fact and conclusions of law as to all claims related to  
6 Dr. Holmes. [Docket No. 153] Plaintiffs did not file proposed findings of fact or conclusions of law as  
7 to their claims related to Dr. Holmes. Having carefully reviewed the evidence and the arguments of  
8 counsel, the Court adopts the United States' proposed findings of fact and conclusions of law as to all  
9 claims related to Dr. Holmes pursuant to Rule 52 of the Federal Rules of Civil Procedure and the Court  
10 grants the United States judgment on partial findings as to all claims related to Dr. Holmes pursuant to  
11 Rule 52(c).

12 The Clerk of the Court is directed to enter partial judgment for the United States as to all claims  
13 related to Dr. Paul Holmes.
