THIRD PARTY COMPLAINT**

25 It is hereby stipulated by and between Third Party Plaintiff OAHU AIR
26 CONDITIONING SERVICE, INC. ("Oahu") and Third Party Defendant "DON SOZZI, AS
27 TRUSTEE OF THE JOYCE SOZZI TRUST" (erroneously named, as Don Sozzi is not a trustee

1 of a Joyce Sozzi Trust) (“Sozzi”) that an extension is granted to respond to the Third Party
2 Complaint to, and including, April 21, 2014. If service was appropriately effected on Joyce
3 Sozzi for the above erroneously named Sozzi on March 10, 2014, which effective service is
4 denied by Sozzi, the response date for Sozzi would be March 31, 2014 and a 21 day extension is
5 being granted. This is the first extension granted by Oahu to Sozzi.
