 24 Court's approval as provided for herein, as follows:

25 RECITALS

26 1. The undersigned defense counsel states he needs more time to exchange necessary
 27 communications with First Solar and the Department of Energy. The communications have been
 28 slowed by the need to assemble a number of DOE employees and by the need to communicate

1 with First Solar attorneys who are on travel in Dubai, United Arab Emirates, whose time zone is
2 about twelve hours ahead of Pacific Time. Email to Dubai has been unreliable, and voice contact
3 is inconvenient.

4 2. The total period of previous continuances of this hearing date is 140 days, and the
5 total of previous extensions of this reply date is 135 days.

6 3. The proposed extension and continuance will not affect a trial date because no trial
7 is scheduled.

8 STIPULATIONS

9 1. That the hearing currently set for November 13, 2014, at 2:00 PM, be
10 CONTINUED for three weeks, until **December 4, 2014**, at 2:00 PM, before Judge England.

11 2. That defendant's time to reply, currently set for October 31, 2014, be EXTENDED
12 for eighteen days, until **November 18, 2014**.
