1 WHEREAS, on April 4, 2016, Plaintiffs filed and served the Consolidated Amended
2 Shareholder Derivative Complaint (the “Amended Complaint”) pursuant to the Stipulation
3 ordered by the Court on February 26, 2016 (ECF No. 115);

4 WHEREAS counsel have identified a discrepancy in the paragraph numbers to the
5 Amended Complaint;

6 WHEREAS counsel for Defendants have proposed a briefing schedule to allow
7 additional time to prepare briefing of a motion to dismiss that will address all claims in the
8 Amended Complaint;

9 WHEREAS counsel for Defendants have proposed page limits to allow additional space
10 for briefing the motion to dismiss;

11 NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between
12 the Plaintiffs and Defendants, by and through their undersigned counsel, as follows:

13 1. Plaintiffs shall refile via ECF the redacted version of their Amended Complaint,
14 within two business days of the Court’s Order, with no content changed other than fixing the
15 discrepancy in consecutive paragraph numbering;

16 2. Defendants shall file and serve a motion(s) in response to the Amended
17 Complaint with one opening brief not to exceed fifty (50) pages on or before June 10, 2016;

18 3. Plaintiffs shall file and serve one opposition brief not to exceed fifty (50) pages on
19 or before August 9, 2016;

20 4. Defendants shall file and serve one reply brief not to exceed twenty-five (25)
21 pages on or before September 9, 2016;
