19 The United States of America applies for an order of publication as follows:

20 1. Rule G(4) of the Supplemental Rules for Admiralty or Maritime Claims
21 and Asset Forfeiture Actions (hereafter "Supplemental Rules") provides that the
22 Plaintiff shall cause public notice of the action to be given in a newspaper of general
23 circulation or on the official internet government forfeiture site;

24 2. Local Rule 171, Eastern District of California, provides that the Court
25 shall designate by order the appropriate newspaper or other vehicle for publication;

26 3. The defendant real property is located in Placerville, California, El Dorado
27 County.

1 4. The United States proposes that publication be made as follows:

2 a. One publication;

3 b. Thirty (30) consecutive days;

4 c. On the official internet government forfeiture site

5 www.forfeiture.gov;

6 d. The publication is to include the following:

7 (1) The Court and case number of the action;

8 (2) The date of the seizure/posting;

9 (3) The identity and/or description of the property seized/posted;

10 (4) The name and address of the attorney for the Plaintiff;

11 (5) A statement that claims of persons entitled to possession or
12 claiming an interest pursuant to Supplemental Rule G(5) must be filed with the Court
13 and served on the attorney for the Plaintiff no later than 60 days after the first day of
14 publication on the official internet government forfeiture site; and

15 (6) A statement that answers to the Complaint or a motion
16 under Rule 12 of the Federal Rules of Civil Procedure ("Fed. R. Civ. P.") must
17 be filed and served within 21 days after the filing of the claims and, in the absence
18 thereof, default may be entered and condemnation ordered.
