22 purposes of these legal proceedings.

23 REBECCA WILSON has been determined, subsequent to a court-ordered
24 psychiatric evaluation, to be presently legally incompetent in regards to pending criminal
25 proceedings (a copy of the Court’s Order of Commitment is attached as Exhibit A).

26 Petitioner has no Guardian ad Litem in this matter nor has she previously sought to
27 have a Guardian ad Litem appointed for the purpose of protecting and advancing her interest
28 in these claims.

1 Heatherlyn Bevard is the mother of Petitioner and is competent to act as the
2 Guardian Ad Litem (a copy of the birth certificate of REBECCA WILSON is attached as
3 Exhibit B).

4 REBECCA WILSON does not have a husband, father, adult child, grandparents,
5 aunt, uncle, or any other family members who are better situated to be a Guardian ad Litem.

6 It is requested that any negotiated resolution of this case require the approval of the
7 Court.

8 WHEREFORE, Petitioner prays that Heatherlyn Bevard be appointed as Guardian
9 Ad Litem for Petitioner in the above-referenced matter.
