1 WHEREAS on December 17, 2013 Plaintiff ThermoGenesis Corporation (“Plaintiff”)
2 filed its Complaint for Patent Infringement (“Complaint”) against Defendant OriGen Biomedical,
3 Inc. (“Defendant”);

4 WHEREAS Defendant’s responsive pleading is currently due January 23, 2014;

5 IT IS HEREBY STIPULATED between Plaintiff and Defendant, through their respective
6 counsel, pursuant to Local Rule 144 and Fed. R. Civ. P. 6(b), that:
