

23 Defendant The Gould Medical Group, Inc.'s Motion for Summary Adjudication is/was
 24 scheduled for hearing on May 6, 2015. Plaintiff Dr. George Savage did not file opposition to
 25 the motion. The Court, having read and considered the matters submitted in support of the
 26 motion, and in the absence of opposition and good cause appearing, hereby grants the motion
 27 on grounds that there are no triable issues of material fact and Defendant The Gould Medical
 28 Group, Inc. is entitled to summary adjudication on Plaintiff's Eighth Cause of Action as to the

1 claim for negligent infliction of emotional distress, only, on grounds that Plaintiff's claim is
2 barred by the exclusive remedy provision of the California Workers' Compensation Act.

3 IT IS HEREBY ORDERED that summary adjudication is GRANTED in favor of
4 Defendant The Gould Medical Group, Inc. and against Plaintiff George Savage on the Eighth
5 Cause of Action as to Plaintiff's negligent infliction of emotional distress claim, only, on the
6 grounds stated above.
