10	Plaintiff, a former state prisoner, has filed with the court an incomprehensible document	
18	styled as an "Affidavit." Out of an abundance of caution, the Clerk of the Court opened this civil	
19	rights action in response to this filing. However, no other pleadings have been filed with the	
20	court by the plaintiff.	
21	In order to commence an action, plaintiff must file a complaint as required by Rule 3 of	
22	the Federal Rules of Civil Procedure, and plaintiff must either pay the required filing fee or file an	
23	application requesting leave to proceed in forma pauperis. ¹ See 28 U.S.C. §§ 1914(a),	
24	1915(a)(1). The court will not issue any orders granting or denying relief until an action has been	
25	properly commenced. Plaintiff will be provided the opportunity to file his complaint, and to

1	submit an application requesting leave to proceed in forma pauperis or to submit the appropriate	
2	filing fee (\$350.00 plus a \$50.00 administrative fee).	
3	In accordance with the above, IT IS HEREBY ORDERED that:	
4	1. Plaintiff is granted thirty days from the date of service of this order to file a complaint	
5	that complies with the requirements of the Civil Rights Act, the Federal Rules of Civil Procedure,	
6	and the Local Rules of Practice; the complaint must bear the docket number assigned this case.	
7	Plaintiff shall also submit, within thirty days from the date of this order, the application to	
8	proceed in forma pauperis on the form provided by the Clerk of Court, or the filing fee in the	
9	amount of \$400.00. Plaintiff's failure to comply with this order will result in a recommendation	
10	that this matter be dismissed; and	
11	2. The Clerk of the Court is directed to send plaintiff a copy of the non-prisoner in forma	
12	pauperis form used by this district.
