21 The parties hereby jointly request a 30-day extension, from February 2, 2018 to March  
22 4, 2018, of the deadline to file any application concerning attorneys' fees, related nontaxable  
23 expenses, or costs.

24 The parties previously stipulated on May 6, 2015, that any motion by any party for  
25 attorneys' fees, related nontaxable expenses, or costs in this action be filed within 30 days of the  
26 judgment of the United States Court of Appeals for the Ninth Circuit, the dismissal of the  
27 appeal for any reason, or the final judgment of this Court on remand, whichever is later. The  
28 Court granted that request on May 11, 2015.

1 The parties believe that the extension requested here will allow them to discuss  
2 settlement of the remaining attorneys' fees issues and thereby possibly avoid unnecessary further  
3 litigation. In addition, additional time is necessary because of the complexity of the litigation,  
4 and because plaintiffs' counsel have had, and will have an unusual number of competing  
5 litigation obligations this month and in the coming month.
