HARRIS, in her official capacity as Attorney General of the State of 10 California, 11 Defendant. 12 13 The parties hereby jointly request a 30-day extension, from March 4, 2018 to April 3, 14 2018, of the deadline to file any application concerning attorneys' fees, related nontaxable 15 expenses, or costs. 16 On May 11, 2015, this Court adopted the parties' stipulation that any motion for 17 attorneys' fees, related nontaxable expenses, or costs in this action be filed within 30 days of the 18 judgment of the U.S. Court of Appeals for the Ninth Circuit, the dismissal of the appeal for any 19 reason, or the final judgment of this Court on remand, whichever is later. 20 Following the Ninth Circuit's recent decision in this case, this Court adopted the parties' 21 stipulation for a 30-day extension of the deadline for a fee motion, to and including March 4, 22 2018. 23 The parties believe that the second extension requested here will allow them to discuss 24 settlement of the remaining attorneys' fees issues and thereby possibly avoid unnecessary 25 further litigation. In addition, additional time is necessary because of the complexity of the 26 litigation, and because plaintiffs' counsel have had, and will have an unusual number of 27 competing litigation obligations this month and in the coming month. 28
