2 plaintiff's opposition to that Motion, (Docket Nos. 100, 102), IT
3 IS HEREBY ORDERED that:

4 (1) Defendant's Ex Parte Motion to Continue Hearing on
5 Defendant's Motion to Stay Injunction Pending Appeal
6 (Docket No. 100) be, and the same hereby is, GRANTED ON
7 THE CONDITIONS that:

8 (i) defendant compensate plaintiff and its counsel for
9 any non-refundable travel arrangements that have
10 already been made for the January 11, 2016
11 hearing; and

12 (ii) the parties, and all those acting in concert with
13 them, understand and agree that unless and until
14 otherwise ordered, the court's September 30, 2015
15 injunction, (Docket Nos. 85-86), remains in full
16 force and effect and shall be complied with in
17 letter and in spirit.

18 (2) The January 11, 2016 hearing date on defendant's Motion
19 to Stay Injunction Pending Appeal (Docket No. 88) is
20 hereby VACATED;

21 (3) A new hearing date on defendant's Motion to Stay
22 Injunction Pending Appeal (Docket No. 88) is set for
23 **February 8, 2016** at 1:30 p.m. in Courtroom 5; and

24 (4) Defendant shall file its reply to plaintiff's
25 opposition to defendant's Motion to Stay Injunction
26 Pending Appeal (Docket No. 99) no later than February
27 1, 2016.
