**STIPULATED REQUEST TO EXTEND TIME
 TO RESPOND TO SECOND AMENDED
 COMPLAINT; ORDER**

1 The parties in the above-captioned case, by and through their counsel of record, hereby represent
2 to the Court as follows:

3 On July 2, 2014, Plaintiffs filed their Second Amended Complaint in the above captioned action,
4 and Defendants CITY OF VACAVILLE, CHIEF RICHARD WORD, OFFICER KINGI and OFFICER
5 VALK's last day to file a responsive pleading currently is July 16, 2014,

6 The Second Amended Complaint adds Officers TORRES and LOPEZ and SERGEANT
7 WILLIAMS as additional defendants,

8 Plaintiffs' counsel forwarded waivers of service of summons to defense counsel for the three new
9 individual defendants on July 2, 2014,

10 To date, Officer TORRES and SERGEANT WILLIAMS have executed and returned the waivers,
11 Defense counsel anticipates receiving the waiver from Officer LOPEZ in the near term,

12 Defendant WILLIAMS' responsive pleading is due September 10, 2014, Officer TORRES'
13 responsive pleading is due September 15, 2014 and Officer LOPEZ' responsive pleading will be due 60
14 days after she executes the waiver,

15 Defendants have agreed not to file a motion to dismiss the Second Amended Complaint and
16 instead will file an Answer thereto,

17 The parties have agreed to extend by two weeks the current July 16, 2014 deadline for the CITY,
18 CHIEF WARD, OFFICER KINGI and OFFICER VALK to file an answer to the Second Amended
19 Complaint so an answer can be filed on behalf of all defendants named in the Second Amended
20 Complaint, including the recently-named individual defendants.

21 Therefore, the parties hereby stipulate to a fourteen (14) day extension of time for defendants to
22 file an answer, through and including July 30, 2014.
