 22 California, Nevada, and relator, named in this action as John Roe, (“Relator”), it is hereby  
 23 ORDERED that



 25 (1) As to the claims stated against defendants Orthopedic Associates of Northern California,  
 26 a Medical Group; Reno Orthopedic Clinic, Dr. Christensen; and San Bernardino Medical  
 27 Orthopaedic Group, Inc., (“Settling Defendants”) this dismissal is in accordance with the  
 28 terms of respective settlement agreements with the Settling Defendants, effective

1 September 23, 2016, (“Agreements”), and is with prejudice as to Relator, with prejudice  
2 as to the United States, California, and Nevada with respect to the Covered Conduct as  
3 defined in the Agreements, and otherwise without prejudice as to the United States,  
4 California, and Nevada.

5 (2) As to the claims stated against defendant Michael T. Keller, M.D., d/b/a San Diego  
6 Arthritis Medical Clinic (SDAMC), the dismissal shall be with prejudice as to Relator  
7 and without prejudice as to the United States, California, and Nevada.
