18	Plaintiff, a state prisoner proceeding pro se, has filed this civil rights action seeking relief	
19	under 42 U.S.C. § 1983. The matter was referred to a United States Magistrate Judge pursuant to	
20	28 U.S.C. § 636(b)(1)(B) and Local Rule 302. On December 26, 2017, plaintiff filed a motion	
20	which requested: (1) that the instant action be dismissed, and (2) that the initial filing fee of	
21	\$350.00 be waived. (<u>See</u> ECF No. 55).	
	On January 9, 2018, the magistrate judge filed findings and recommendations herein	
23	recommending that the motion be granted in part and denied in part. (ECF No. 57). The findings	
24	and recommendations were served on all parties and contained notice to all parties that any	
25	objections to the findings and recommendations were to be filed within twenty-one days. (ECF	
26	No. 57). Neither party has filed objections to the findings and recommendations.

1	The court has reviewed the file and finds the findings and recommendations to be

7	DENIED in part as follows:	
8	a. Plaintiff's request to dismiss the complaint is GRANTED. The action is

10	b. Plaintiff's request to have the \$350.00 filing fee waived in the matter is DENIED.
