8 by the Court, to be entered after the earlier of notice by the parties that they have resolved the case, or
9 the Supreme Court's decision in *Spokeo, Inc. v. Robins*, No. 13-1339; and

12 the Supreme Court has entered a decision in *Spokeo, Inc. v. Robins*, No. 13-1339.
