17 Defendants.18 1. PURPOSES AND LIMITATIONS

19 Disclosure and discovery activity in this action are likely to involve production of  
20 confidential, proprietary, or private information for which special protection from public  
21 disclosure and from use for any purpose other than prosecuting this litigation may be warranted.  
22 Accordingly, the parties hereby stipulate to and petition the court to enter the following Stipulated  
23 Protective Order. The parties acknowledge that this Order does not confer blanket protections on  
24 all disclosures or responses to discovery and that the protection it affords from public disclosure  
25 and use extends only to the limited information or items that are entitled to confidential treatment  
26 under the applicable legal principles. The parties further acknowledge, as set forth in Section 12.3,  
27 below, that this Stipulated Protective Order does not entitle them to file confidential information  
28 under seal and that Civil Local Rule 141 sets forth the procedures that must be followed and the

standards that will be applied when a party seeks permission from the court to file material under seal.

## 2. DEFINITIONS

2.1 Challenging Party: a Party or Non-Party that challenges the designation of information or items under this Order.

2.2 “CONFIDENTIAL” Information or Items: information (regardless of how it is generated, stored or maintained) or tangible things that qualify for protection under Federal Rule of Civil Procedure 26(c).

2.3 Counsel (without qualifier): Outside Counsel of Record and House Counsel (as well as their support staff).

2.4 Designating Party: a Party or Non-Party that designates information or items that it produces in disclosures or in responses to discovery as “CONFIDENTIAL.”

2.5 Disclosure or Discovery Material: all items or information, regardless of the medium or manner in which it is generated, stored, or maintained (including, among other things, testimony, transcripts, and tangible things), that are produced or generated in disclosures or responses to discovery in this matter.

2.6 Expert: a person with specialized knowledge or experience in a matter pertinent to the litigation who has been retained by a Party or its counsel to serve as an expert witness or as a consultant in this action.

2.7 House Counsel: attorneys who are employees of a party to this action. House Counsel does not include Outside Counsel of Record or any other outside counsel.

2.8 Non-Party: any natural person, partnership, corporation, association, or other legal entity not named as a Party to this action.

2.9 Outside Counsel of Record: attorneys who are not employees of a party to this action but are retained to represent or advise a party to this action and have appeared in this action on behalf of that party or are affiliated with a law firm which has appeared on behalf of that party.

2.10 Party: any party to this action, including all of its officers, directors, employees, consultants, retained experts, and Outside Counsel of Record (and their support staffs).

2.11 Producing Party: a Party or Non-Party that produces Disclosure or Discovery Material in this action.

2.12 Professional Vendors: persons or entities that provide litigation support services (e.g., photocopying, videotaping, translating, preparing exhibits or demonstrations, and organizing, storing, or retrieving data in any form or medium) and their employees and subcontractors.

2.13 Protected Material: any Disclosure or Discovery Material that is designated as “CONFIDENTIAL.”

2.14 Receiving Party: a Party that receives Disclosure or Discovery Material from a Producing Party.

### 3. SCOPE

The protections conferred by this Stipulation and Order cover not only Protected Material (as defined above), but also (1) any information copied or extracted from Protected Material; (2) all copies, excerpts, summaries, or compilations of Protected Material; and (3) any testimony, conversations, or presentations by Parties or their Counsel that might reveal Protected Material. However, the protections conferred by this Stipulation and Order do not cover the following information: (a) any information that is in the public domain at the time of disclosure to a Receiving Party or becomes part of the public domain after its disclosure to a Receiving Party as a result of publication not involving a violation of this Order, including becoming part of the public record through trial or otherwise; and (b) any information known to the Receiving Party prior to the disclosure or obtained by the Receiving Party after the disclosure from a source who obtained the information lawfully and under no obligation of confidentiality to the Designating Party. Any use of Protected Material at trial shall be governed by a separate agreement or order.

### 4. DURATION

Even after final disposition of this litigation, the confidentiality obligations imposed by this Order shall remain in effect until a Designating Party agrees otherwise in writing or a court order otherwise directs. Final disposition shall be deemed to be the later of (1) dismissal of all claims and defenses in this action, with or without prejudice; and (2) final judgment herein after the

1 completion and exhaustion of all appeals, rehearings, remands, trials, or reviews of this action,  
2 including the time limits for filing any motions or applications for extension of time pursuant to  
3 applicable law.

4 5. DESIGNATING PROTECTED MATERIAL

5 5.1 Exercise of Restraint and Care in Designating Material for Protection. Each Party  
6 or Non-Party that designates information or items for protection under this Order must take care to  
7 limit any such designation to specific material that qualifies under the appropriate standards. The  
8 Designating Party must designate for protection only those parts of material, documents, items, or  
9 oral or written communications that qualify – so that other portions of the material, documents,  
10 items, or communications for which protection is not warranted are not swept unjustifiably within  
11 the ambit of this Order.

12 Mass, indiscriminate, or routinized designations are prohibited. Designations that are  
13 shown to be clearly unjustified or that have been made for an improper purpose (e.g., to  
14 unnecessarily encumber or retard the case development process or to impose unnecessary  
15 expenses and burdens on other parties) expose the Designating Party to sanctions.

16 If it comes to a Designating Party's attention that information or items that it designated for  
17 protection do not qualify for protection, that Designating Party must promptly notify all other  
18 Parties that it is withdrawing the mistaken designation.

19 5.2 Manner and Timing of Designations. Except as otherwise provided in this Order  
20 (see, e.g., second paragraph of section 5.2(a) below), or as otherwise stipulated or ordered,  
21 Disclosure or Discovery Material that qualifies for protection under this Order must be clearly so  
22 designated before the material is disclosed or produced.

23 Designation in conformity with this Order requires:

24 (a) for information in documentary form (e.g., paper or electronic documents, but  
25 excluding transcripts of depositions or other pretrial or trial proceedings), that the Producing Party  
26 affix the legend "CONFIDENTIAL" to each page that contains protected material. If only a  
27 portion or portions of the material on a page qualifies for protection, the Producing Party also must  
28 clearly identify the protected portion(s) (e.g., by making appropriate markings in the margins).

1 A Party or Non-Party that makes original documents or materials available for inspection need not  
2 designate them for protection until after the inspecting Party has indicated which material it would  
3 like copied and produced. During the inspection and before the designation, all of the material  
4 made available for inspection shall be deemed “CONFIDENTIAL.” After the inspecting Party has  
5 identified the documents it wants copied and produced, the Producing Party must determine which  
6 documents, or portions thereof, qualify for protection under this Order. Then, before producing the  
7 specified documents, the Producing Party must affix the “CONFIDENTIAL” legend to each page  
8 that contains Protected Material. If only a portion or portions of the material on a page qualifies  
9 for protection, the Producing Party also must clearly identify the protected portion(s) (e.g., by  
10 making appropriate markings in the margins).

11 (b) for testimony given in deposition or in other pretrial or trial proceedings, that the  
12 Designating Party identify on the record, before the close of the deposition, hearing or other  
13 proceeding, all protected testimony that contains confidential information, may be designated  
14 “CONFIDENTIAL” and thereby obtain the protections accorded other “CONFIDENTIAL”  
15 information.

16 (c) for information produced in some form other than documentary and for any other  
17 tangible items, that the Producing Party affix in a prominent place on the exterior of the container  
18 or containers in which the information or item is stored the legend “CONFIDENTIAL.” If only a  
19 portion or portions of the information or item warrant protection, the Producing Party, to the  
20 extent practicable, shall identify the protected portion(s).

21 5.3 Inadvertent Failures to Designate. If timely corrected, an inadvertent failure to  
22 designate qualified information or items does not, standing alone, waive the Designating Party’s  
23 right to secure protection under this Order for such material. Upon timely correction of a  
24 designation, the Receiving Party must make reasonable efforts to assure that the material is treated  
25 in accordance with the provisions of this Order.

## 26 6. CHALLENGING CONFIDENTIALITY DESIGNATIONS

27 6.1 Timing of Challenges. Any Party or Non-Party may challenge a designation of  
28 confidentiality at any time. Unless a prompt challenge to a Designating Party’s confidentiality

1 designation is necessary to avoid foreseeable, substantial unfairness, unnecessary economic  
2 burdens, or a significant disruption or delay of the litigation, a Party does not waive its right to  
3 challenge a confidentiality designation by electing not to mount a challenge promptly after the  
4 original designation is disclosed.

5         6.2     Meet and Confer. The Challenging Party shall initiate the dispute resolution  
6 process by providing written notice of each designation it is challenging and describing the basis  
7 for each challenge. To avoid ambiguity as to whether a challenge has been made, the written  
8 notice must recite that the challenge to confidentiality is being made in accordance with this  
9 specific paragraph of the Protective Order. The parties shall attempt to resolve each challenge in  
10 good faith and must begin the process by conferring directly (in voice to voice dialogue; other  
11 forms of communication are not sufficient) within 14 days of the date of service of notice. In  
12 conferring, the Challenging Party must explain the basis for its belief that the confidentiality  
13 designation was not proper and must give the Designating Party an opportunity to review the  
14 designated material, to reconsider the circumstances, and, if no change in designation is offered, to  
15 explain the basis for the chosen designation. A Challenging Party may proceed to the next stage of  
16 the challenge process only if it has engaged in this meet and confer process first or establishes that  
17 the Designating Party is unwilling to participate in the meet and confer process in a timely  
18 manner.

19         6.3     Judicial Intervention. If the Parties cannot resolve a challenge without court  
20 intervention, the Designating Party shall file and serve a motion to retain confidentiality under  
21 Civil Local Rule 141.1, if applicable, within 21 days of the initial notice of challenge or within 14  
22 days of the parties agreeing that the meet and confer process will not resolve their dispute,  
23 whichever is later. Each such motion must be accompanied by a competent declaration affirming  
24 that the movant has complied with the meet and confer requirements imposed in the preceding  
25 paragraph. Failure by the Designating Party to make such a motion including the required  
26 declaration within 21 days (or 14 days, if applicable) shall automatically waive the confidentiality  
27 designation for each challenged designation. In addition, the Challenging Party may file a motion  
28 challenging a confidentiality designation at any time if there is good cause for doing so, including

1 a challenge to the designation of a deposition transcript or any portions thereof. Any motion  
2 brought pursuant to this provision must be accompanied by a competent declaration affirming that  
3 the movant has complied with the meet and confer requirements imposed by the preceding  
4 paragraph.

5 The burden of persuasion in any such challenge proceeding shall be on the Designating  
6 Party. Frivolous challenges, and those made for an improper purpose (e.g., to harass or impose  
7 unnecessary expenses and burdens on other parties) may expose the Challenging Party to  
8 sanctions. Unless the Designating Party has waived the confidentiality designation by failing to  
9 file a motion to retain confidentiality as described above, all parties shall continue to afford the  
10 material in question the level of protection to which it is entitled under the Producing Party's  
11 designation until the court rules on the challenge.

## 12 7. ACCESS TO AND USE OF PROTECTED MATERIAL

13 7.1 Basic Principles. A Receiving Party may use Protected Material that is disclosed or  
14 produced by another Party or by a Non-Party in connection with this case only for prosecuting,  
15 defending, or attempting to settle this litigation. Such Protected Material may be disclosed only to  
16 the categories of persons and under the conditions described in this Order. When the litigation has  
17 been terminated, a Receiving Party must comply with the provisions of section 13 below (FINAL  
18 DISPOSITION).

19 Protected Material must be stored and maintained by a Receiving Party at a location and in  
20 a secure manner that ensures that access is limited to the persons authorized under this Order.

21 7.2 Disclosure of "CONFIDENTIAL" Information or Items. Unless otherwise ordered  
22 by the court or permitted in writing by the Designating Party, a Receiving Party may disclose any  
23 information or item designated "CONFIDENTIAL" only to:

24 (a) the Receiving Party's Outside Counsel of Record in this action, as well as  
25 employees of said Outside Counsel of Record to whom it is reasonably necessary to disclose the  
26 information for this litigation and who have signed the Acknowledgement and Agreement to be  
27 Bound (Exhibit "A") ;

28 (b) the officers, directors, and employees (including House Counsel) of the Receiving

1 Party to whom disclosure is reasonably necessary for this litigation;

2 (c) Experts (as defined in this Order) of the Receiving Party to whom disclosure is  
3 reasonably necessary for this litigation and who have signed the “Acknowledgment and  
4 Agreement to Be Bound” (Exhibit A);

5 (d) the court and its personnel;

6 (e) court reporters and their staff, professional jury or trial consultants, mock jurors,  
7 and Professional Vendors to whom disclosure is reasonably necessary for this litigation and who  
8 have signed the “Acknowledgment and Agreement to Be Bound” (Exhibit A);

9 (f) during their depositions, witnesses in the action to whom disclosure is reasonably  
10 necessary and who have signed the “Acknowledgment and Agreement to Be Bound” (Exhibit A),  
11 unless otherwise covered in subparagraphs 7.2(a)-(e) or agreed by the Designating Party or  
12 ordered by the court. Pages of transcribed deposition testimony or exhibits to depositions that  
13 reveal Protected Material must be separately bound by the court reporter and may not be disclosed  
14 to anyone except as permitted under this Stipulated Protective Order.

15 (g) the author or recipient of a document containing the information or a custodian or  
16 other person who otherwise possessed or knew the information.

17 8. PROTECTED MATERIAL SUBPOENAED OR ORDERED PRODUCED IN OTHER  
18 LITIGATION

19 If a Party is served with a subpoena or a court order issued in other litigation that compels  
20 disclosure of any information or items designated in this action as “CONFIDENTIAL,” that Party  
21 must:

22 (a) promptly notify in writing the Designating Party. Such notification shall include a  
23 copy of the subpoena or court order;

24 (b) promptly notify in writing the party who caused the subpoena or order to issue in  
25 the other litigation that some or all of the material covered by the subpoena or order is subject to  
26 this Protective Order. Such notification shall include a copy of this Stipulated Protective Order;  
27 and

28 (c) cooperate with respect to all reasonable procedures sought to be pursued by the

1 Designating Party whose Protected Material may be affected.

2 If the Designating Party timely seeks a protective order, the Party served with the subpoena  
3 or court order shall not produce any information designated in this action as “CONFIDENTIAL”  
4 before a determination by the court from which the subpoena or order issued, unless the Party has  
5 obtained the Designating Party’s permission. The Designating Party shall bear the burden and  
6 expense of seeking protection in that court of its confidential material – and nothing in these  
7 provisions should be construed as authorizing or encouraging a Receiving Party in this action to  
8 disobey a lawful directive from another court.

9 9. A NON-PARTY’S PROTECTED MATERIAL SOUGHT TO BE PRODUCED IN THIS  
10 LITIGATION

11 (a) The terms of this Order are applicable to information produced by a Non-Party in  
12 this action and designated as “CONFIDENTIAL.” Such information produced by Non-Parties in  
13 connection with this litigation is protected by the remedies and relief provided by this Order.  
14 Nothing in these provisions should be construed as prohibiting a Non-Party from seeking  
15 additional protections.

16 (b) In the event that a Party is required, by a valid discovery request, to produce a  
17 Non-Party’s confidential information in its possession, and the Party is subject to an agreement  
18 with the Non-Party not to produce the Non-Party’s confidential information, then the Party shall:

19 (1) promptly notify in writing the Requesting Party and the Non-Party that some or  
20 all of the information requested is subject to a confidentiality agreement with a Non-Party;

21 (2) promptly provide the Non-Party with a copy of the Stipulated Protective Order  
22 in this litigation, the relevant discovery request(s), and a reasonably specific description of the  
23 information requested; and

24 (3) make the information requested available for inspection by the Non-Party.

25 (c) If the Non-Party fails to object or seek a protective order from this court within 14  
26 days of receiving the notice and accompanying information, the Receiving Party may produce the  
27 Non-Party’s confidential information responsive to the discovery request. If the Non-Party timely  
28 seeks a protective order, the Receiving Party shall not produce any information in its possession or

control that is subject to the confidentiality agreement with the Non-Party before a determination by the court. Absent a court order to the contrary, the Non-Party shall bear the burden and expense of seeking protection in this court of its Protected Material.

10. UNAUTHORIZED DISCLOSURE OF PROTECTED MATERIAL

If a Receiving Party learns that, by inadvertence or otherwise, it has disclosed Protected Material to any person or in any circumstance not authorized under this Stipulated Protective Order, the Receiving Party must immediately (a) notify in writing the Designating Party of the unauthorized disclosures, (b) use its best efforts to retrieve all unauthorized copies of the Protected Material, (c) inform the person or persons to whom unauthorized disclosures were made of all the terms of this Order, and (d) request such person or persons to execute the “Acknowledgment and Agreement to Be Bound” that is attached hereto as Exhibit A.

11. INADVERTENT PRODUCTION OF PRIVILEGED OR OTHERWISE PROTECTED MATERIAL

When a Producing Party gives notice to Receiving Parties that certain inadvertently produced material is subject to a claim of privilege or other protection, the obligations of the Receiving Parties are those set forth in Federal Rule of Civil Procedure 26(b)(5)(B). This provision is not intended to modify whatever procedure may be established in an e-discovery order that provides for production without prior privilege review. Pursuant to Federal Rule of Evidence 502(d) and (e), insofar as the parties reach an agreement on the effect of disclosure of a communication or information covered by the attorney-client privilege or work product protection, the parties may incorporate their agreement in the stipulated protective order submitted to the court.

12. MISCELLANEOUS

12.1 Right to Further Relief. Nothing in this Order abridges the right of any person to seek its modification by the court in the future, and nothing in this Protective Order shall be construed to prevent a Party from seeking such further provisions enhancing or limiting confidentiality as may be appropriate.

1           12.2   Right to Assert Other Objections. By stipulating to the entry of this Protective  
2   Order no Party waives any right it otherwise would have to object to disclosing or producing any  
3   information or item on any ground not addressed in this Stipulated Protective Order. Similarly, no  
4   Party waives any right to object on any ground to use in evidence of any of the material covered  
5   by this Protective Order.

6           12.3   Filing Protected Material. Without written permission from the Designating Party  
7   or a court order secured after appropriate notice to all interested persons, a Party may not file in  
8   the public record in this action any Protected Material. A Party that seeks to file under seal any  
9   Protected Material must comply with Civil Local Rule 141. Protected Material may only be filed  
10   under seal pursuant to a court order authorizing the sealing of the specific Protected Material at  
11   issue. Pursuant to Civil Local Rule 141 a sealing order will issue only upon a request establishing  
12   that the Protected Material at issue is privileged, protectable as a trade secret, or otherwise entitled  
13   to protection under the law. If a Receiving Party's request to file Protected Material under seal  
14   pursuant to Civil Local Rule 141 is denied by the court, then the Receiving Party may file the  
15   information in the public record pursuant to Civil Local Rule 141 unless otherwise instructed by  
16   the court.

17           12.4   Waiver. No action taken in accordance with this Protective Order shall be  
18   construed as a waiver of any claim or defense in the action or of any position as to discoverability  
19   or admissibility of evidence. Neither the entry of this Order nor the designation of any  
20   information as "Confidential," nor the failure to make such designation, shall constitute evidence  
21   with respect to any issue in this action.

22           12.5   The Court retains the right to allow disclosure of any subject covered by this  
23   stipulation or to modify this stipulation at any time in the interest of justice.

24   13.    FINAL DISPOSITION

25           Within 60 days after the final disposition of this action, as defined in paragraph 4, each  
26   Receiving Party must return all Protected Material to the Producing Party or destroy such material.  
27   As used in this subdivision, "all Protected Material" includes all copies, abstracts, compilations,  
28   summaries, and any other format reproducing or capturing any of the Protected Material. Whether

the Protected Material is returned or destroyed, the Receiving Party must submit a written certification to the Producing Party (and, if not the same person or entity, to the Designating Party) by the 60 day deadline that (1) identifies (by category, where appropriate) all the Protected Material that was returned or destroyed and (2) affirms that the Receiving Party has not retained any copies, abstracts, compilations, summaries or any other format reproducing or capturing any of the Protected Material. Notwithstanding this provision, Counsel are entitled to retain an archival copy of all pleadings, motion papers, trial, deposition, and hearing transcripts, legal memoranda, correspondence, deposition and trial exhibits, expert reports, attorney work product, and consultant and expert work product, even if such materials contain Protected Material. Any such archival copies that contain or constitute Protected Material remain subject to this Protective Order as set forth in Section 4 (DURATION).
