3 defendants CITY OF REDDING, a municipal corporation; ROBERT F. PAOLETTI, JARED
4 HEBERT, WES TOWNSLEY, BRANDON LARGENT, BECKY ZUFALL, CHRIS JACOBY
5 (hereinafter referred to as the “S M-B, et al. v. CITY OF REDDING, et al.”) hereby submit the
6 following Stipulation to Consolidate Related Cases:

25 al. v. CITY OF REDDING, et al. action be consolidated with the L.M., et al. v. CITY OF
26 REDDING, et al. action and assigned to the Honorable Morrison C. England, Jr. for all
27 purposes.
