1 Plaintiff Keith Welday and defendant Rite Aid Corporation (“Rite Aid”), acting through their  
2 respective counsel of record, hereby stipulate as follows:

3 1. This is one of 10 related actions pending before the Court: *Keith Welday v. Rite Aid*  
4 *Corp.*, 2:13-CV-02439 JAM-EFB (“*Welday*”); *Tom Bauser v. Rite Aid Corp.*, 2:14-CV-01946 JAM-EFB  
5 (“*Bauser*”); *Rachel Chavez v. Rite Aid Corp.*, 2:14-CV-01957 JAM-EFB (“*Chavez*”); *Mark Jaeger v.*  
6 *Rite Aid Corp.*, 2:14-CV-01960 JAM-EFB (“*Jaeger*”); *Bruce Kaufman v. Rite Aid Corp.*, 2:14-CV-  
7 01961 JAM-EFB (“*Kaufman*”); *Chris Gonzalez v. Rite Aid Corp.*, 2:14-CV-01963 JAM-EFB  
8 (“*Gonzalez*”); *Kathryn Von Kopp v. Rite Aid Corp.*, 2:14-CV-01965 JAM-EFB (“*Von Kopp*”); *Kevin*  
9 *Lewis v. Rite Aid Corp.*, 2:15-CV-00429 JAM-EFB (“*Lewis*”); *Jeff Wise v. Rite Aid Corp.*, 2:15-CV-  
10 00622 JAM-EFB (“*Wise*”); and *Paul Neumann v. Rite Aid Corp.*, 2:15-CV-00623 JAM-EFB  
11 (“*Neumann*”) (collectively the “Related Actions”).

12 2. On March 4, 2015, Rite Aid moved to stay *Welday*, *Bauser*, *Chavez*, *Jaeger*, *Kaufman*,  
13 *Gonzalez*, and *Von Kopp* pending *Romero v. Rite Aid Corp.*, U.S.D.C., C.D. Cal., No. CV 13-7720-  
14 MWF (JEMx) (“*Romero*”), a putative class action in which the plaintiff alleges that Rite Aid  
15 misclassified salaried Store Managers as exempt from the overtime pay and related requirements of  
16 California law. Because the plaintiffs in *Welday*, *Bauser*, *Chavez*, *Jaeger*, *Kaufman*, *Gonzalez*, and *Von*  
17 *Kopp* and the putative class in *Romero* are represented by the same counsel and plaintiffs in *Welday*,  
18 *Bauser*, *Chavez*, *Jaeger*, *Kaufman*, *Gonzalez*, and *Von Kopp* are putative class member in *Romero*, Rite  
19 Aid contended that the Court here should stay these proceedings as an effective case management tool  
20 under its inherent discretionary authority. *See Landis v. North American Co.*, 299 U.S. 248, 254-55  
21 (1936). (*See, e.g., Welday* ECF 26.) Rite Aid’s motions to stay remain pending before the Court,  
22 though the hearings were vacated on April 16, 2015. (*See, e.g., Welday* ECF 34.) No such motions  
23 were filed in *Lewis*, *Wise*, or *Neumann*.

24 3. On March 2, 2015, separate counsel filed against Rite Aid a multi-plaintiff and putative  
25 class action in Santa Clara County Superior Court entitled *Chavez v. Rite Aid Corp.*, Santa Clara Super.  
26 Ct. No. 1-15-CV-277313 (“*Chavez II*”) in which the plaintiffs allege that Rite Aid misclassified salaried  
27 Store Managers as exempt from the overtime pay and related requirements of California law.
