Examination of the above-entitled actions reveals that these actions are related within the meaning of Local Rule 123 (E.D. Cal. 2005). Accordingly, the assignment of the matters to the same judge and magistrate judge is likely to affect a substantial savings of

3 The parties should be aware that relating the cases under

8 magistrate judge to whom the first filed action was assigned.

9 IT IS THEREFORE ORDERED that the actions denominated 2:15-CV-  
10 00622 TLN-CMK and Case No. 2:15-CV-00623 MCE-EFB be reassigned to  
11 Judge John A. Mendez and Magistrate Judge Edmund F. Brennan for all  
12 further proceedings, and any dates currently set in this reassigned  
13 case only are hereby VACATED. Henceforth, the caption on documents  
14 filed in the reassigned cases shall be shown as 2:15-CV-00622 JAM-  
15 EFB and Case No. 2:15-CV-00623 JAM-EFB.

16 IT IS FURTHER ORDERED that the Clerk of the Court make  
17 appropriate adjustment in the assignment of civil cases to  
18 compensate for this reassignment.
