The United States has provided mail service to all known 24 potential claimants and is attempting personal service on several of those who received 25 mail notice. Additionally, public notice on the official internet government forfeiture site, 26 www.forfeiture.gov, began on September 4, 2014, and ran for 30 consecutive days. A 27 Declaration of Publication was filed on October 29, 2014.

On October 1, 2014, Newton Mancia filed a claim alleging an interest in the 1 defendant currency and filed an answer to the complaint on October 15, 2014. No other 2 party has entered this case. 3 Upon receipt of the personal service Process Receipt and Returns from the U.S. 4 Marshals Service, the United States intends on obtaining clerk's defaults against the 5 potential claimants who have not filed claims in this action.
