24 IT IS HEREBY STIPULATED, by and between Dorrance Byrd (Plaintiff)  
25 and Carolyn W. Colvin, Acting Commissioner of Social Security (the Commissioner  
26 or Defendant), through their respective counsel of record, that this action be  
27 remanded for further administrative action pursuant to section 205(g) of the Social  
28 Security Act, as amended, 42 U.S.C. section 405(g), sentence four and for entry of  
judgment. On remand, the Appeals Council will remand the case to an

1 administrative law judge (ALJ) for a new hearing and decision. The Appeals  
2 Council will instruct the ALJ to reconcile both applications, and in so doing, obtain  
3 evidence from a medical expert, reevaluate whether Plaintiff meets or medically  
4 equals Listing 12.05C, and continue through the sequential evaluation, as warranted.


