17 The United States requests that the Court continue the Pretrial Scheduling
18 Conference from January 5, 2015 to April 13, 2015 at 2:00 p.m.

19 **Introduction**

20 On September 4, 2014, the United States filed a civil forfeiture complaint against
21 the above-captioned currency (“Defendant Currency”) based on its alleged involvement in
22 federal drug law violations. (ECF #1).

23 The Court set a Pretrial Scheduling Conference for January 5, 2015 at 2:00 pm.
24 (ECF #2).

25 The United States served notice on all potential claimants and filed certificates of
26 service. (ECF #5-11). No claimants have entered this case.

27 On December 8, 2014, after the deadline for claimants to enter the case expired, the
28 United States requested the entry of Clerk’s Default. (ECF #12). Clerk’s Default was

1 entered on December 9, 2014. (ECF #13). In the next 30-60 days the United States
2 intends to file a motion for default judgment and final judgment of forfeiture, which would
3 end this case.

4 **Good Cause**

5 Thus, for reasons of judicial economy, there is good cause to continue the Pretrial
6 Scheduling Conference in this case from January 5, 2015 to April 13, 2015 (or to another
7 date the Court deems appropriate).
