While still 20 incarcerated at Salinas Valley State Prison, plaintiff informed the court that he preferred to appear 21 electronically. See ECF No. 67. Plaintiff was subsequently transferred to California State Prison Sacramento (CSP-SAC), 1 22 23 which is much closer to the federal courthouse where the settlement conference will be held.
