
**ORDER GRANTING DEFENDANT

16 For good cause shown, **IT IS HEREBY ORDERED** that:

- 17 1. Defendant Seleaina Thomas' ex parte application is GRANTED. The July 2,  
 18 2015 Order scheduling an August 18, 2015 Settlement Conference is VACATED. The  
 19 settlement conference before Magistrate Judge Kendall J. Newman is reset for October 28, 2015,

 25 person may result in the imposition of sanctions. In addition, the conference will not proceed  
 26 and will be reset to another date.

3 his non-confidential settlement statement to arrive not less than seven days prior to the settlement

5 4-200, Sacramento, CA 95814. The envelope shall be marked "Settlement Statement." If a  
6 party desires to share additional confidential information with the Court, they may do so  
7 pursuant to the provisions of Local Rule 270(d) and (e).
