**ORDER GRANTING PLAINTIFF'S EX
PARTE APPLICATION FOR WRIT OF
POSSESSION**

FINDINGS

Plaintiff's ex parte application for a writ of possession
having been considered by the Court, the Court finds as follows:

1. Plaintiff has established the probable validity of his
claim to possession of the following property: 2005
Hummer H2, VIN 5GRN23U85H117259, California Plate
7FUW750, Kansas Title AA3304411;
2. There is probable cause to believe this property or
some part of it is located at the following private
place: 6672 Halsey Street, Shawnee, Kansas 66216;

1 3. Defendant gained possession of the property described
2 above, and (1) the property is not necessary for support
3 of Defendant or Defendant's family; (2) there is an
4 immediate danger that the property will become
5 unavailable to levy by reason of being transferred,
6 concealed, or removed from the state, or will become
7 substantially impaired in value by acts of destruction,
8 or by failure to take care of the property in a
9 reasonable manner; and (3) the ex parte issuance of a
10 writ of possession is necessary to protect the property;
11 and

12 4. Plaintiff is required to file an undertaking in the
13 amount of \$20,000.

15 ORDER

16 To the Sheriff or any Marshal or authorized law enforcement
17 officer of the County of Johnson, City of Shawnee, State of
18 Kansas - you are directed:

- 19 1. To levy upon and retain in your custody, until
20 released or sold (Code Civ. Proc., § 514.030), the
21 following property or any part of it: 2005 Hummer H2, VIN
22 5GRN23U85H117259, California Plate 7FUW750, Kansas Title
23 AA3304411;
- 24 2. To enter the following private place or places to take
25 possession of the above-described property or some part
26 of it: 6672 Halsey Street, Shawnee, Kansas 66216; and
- 27 3. To return this writ and the certificate of your
28 proceedings within 30 days after levy and service, but in

1 no event later than 60 days after issuance of this writ.

2

3 It is further ordered that Plaintiff file a written
4 undertaking in the amount of \$20,000 and attach a copy of the
5 undertaking to this writ of possession;
