**STIPULATION AND ORDER
 MODIFYING BRIEFING

1 WHEREAS, Defendants Wal-Mart, Stores, Inc. and American International

20 1. Plaintiffs’ Opposition brief is due on or before May 27, 2015;
- 21 2. Defendants’ Reply brief is due on or before June 10, 2015; and
- 22 3. The hearing on Defendants’ Motion to Dismiss shall be held on June 24,
23 2015, at 10:00 a.m. before Magistrate Judge Kellison.


