**STIPULATION AND ORDER

5 **WHEREAS**, on February 22, 2016, this Court entered an Order Adopting the Findings
6 and Recommendations of Magistrate Judge Kellison filed on September 2, 2015, in full;

7 **WHEREAS**, pursuant to the February 22, 2016, Order, this Court granted Plaintiff
8 leave to amend the Complaint “within 30 days of the date of [the] order” which was due on or
9 before March 23, 2016;

10 **WHEREAS**, Plaintiff, who was previously represented *in pro per*, retained counsel,
11 Joseph M. Alioto of the Alioto Law Firm, who entered his appearance in this case on March
12 11, 2016 (Dkt. Nos. 46 and 47);

13 **WHEREAS**, after Plaintiffs’ retention of counsel, the parties stipulated and the Court
14 ordered the time extended for Plaintiff to file a Second Amended Complaint to on or before
15 April 21, 2016;

16 **AND WHEREAS**, in light of urgent matters that have arisen since the first stipulation
17 was filed, and counsel for Plaintiff’s continuing review of the case, Plaintiff and Defendants
18 have conferred and agreed that, subject to the Court’s approval, the deadline for filing
19 Plaintiff’s Second Amended Complaint is extended to on or before May 20, 2016.
