5	may result in the imposition of any appropriate sanctions.	
6	4. Similarly, if any of the attorneys for the parties approve communications that can be in	
7	any way construed as disparaging or not conducive to the settlement proceedings, such	
8	attorneys may likewise be sanctioned.
