14 Examination of the above-entitled actions reveals that they are related within the meaning
15 of Local Rule 123(a) (E.D. Cal. 1997). The actions involve the same parties, are based on the
16 same claims, the same questions of fact and the same questions of law, and would therefore entail
17 a substantial duplication of labor if heard by different judges. Accordingly, the assignment of the
18 matters to the same judge is likely to affect a substantial savings of judicial effort.

19 The parties should be aware that relating the cases under Local Rule 123 merely has the
20 result that these actions are assigned to the same judge. No consolidation of the actions is
21 affected. Under the regular practice of this court, related cases are generally assigned to the judge
22 and magistrate judge to whom the first filed action was assigned.

23 IT IS THEREFORE ORDERED that the actions denominated 2:17-cv-00072-TLN-CMK
24 2:17-cv-00071-WBS-CMK, 2:17-cv-00073-MCE-CMK, 2:17-cv-00082-MCE-CMK, 2:17-cv-
25 00069-TLN-CMK, and 2:17-cv-00074-WBS-CMK are hereby reassigned to District Judge Troy
26 L. Nunley and Magistrate Judge Kendall Newman for all further proceedings. Any dates
27 currently set in the reassigned cases are hereby VACATED. Henceforth, the caption on
28 documents filed in the reassigned cases shall be shown as: 2:17-cv-00072-TLN-KJN 2:17-cv-
00071-TLN-KJN, 2:17-cv-00073-TLN-KJN, 2:17-cv-00082-TLN-KJN, 2:17-cv-00069-TLN-

1 KJN, and 2:17-cv-00074-TLN-KJN, respectively.


2 IT IS FURTHER ORDERED that the Clerk of Court make appropriate adjustments in the
