Zidehsarai are jointly and severally indebted to 5 the United States in the amount of \$442,567.94 plus statutory interest and other statutory 6 additions running from October 28, 2016, which represents the unpaid balance of the federal 7 individual income tax (Form 1040) liabilities assessed against Behrooz Zidehsarai and Justina V. 8 Zidehsarai for the taxable years ending December 31, 2004, through and including December 31, 9 2009, excluding penalties and interest on penalties for those tax years, together with accrued but 10 unassessed interest and other statutory additions, together with statutory interest and other statutory additions accruing thereafter pursuant to 28 U.S.C. § 1961(c) and 26 U.S.C. §§ 6601, 11 12 6621, and 6622, until the judgment is paid; and

The Clerk of the Court shall issue a Partial Judgment consistent with this Order.
