STIPULATION AND ORDER 13 EXTENDING TIME FOR FILING A COMPLAINT FOR FORFEITURE 14 APPROXIMATELY \$67,646.00 IN U.S. AND/OR TO OBTAIN AN INDICTMENT CURRENCY. ALLEGING FORFEITURE 15 Defendant 16 17 It is hereby stipulated by and between the United States of America and claimant Cedric Sewell ("claimant"), by and through their respective counsel, as follows: 18 1. On or about June 10, 2014, claimant Cedric Sewell filed a claim, in the administrative 19 forfeiture proceedings, with the Federal Bureau of Investigation with respect to the Approximately 20 \$67,646.00 in U.S. Currency (hereafter "defendant currency"), which was seized on March 5, 2014. 21 2. 22 The Federal Bureau of Investigation has sent the written notice of intent to forfeit required by 18 U.S.C. § 983(a)(1)(A) to all known interested parties. The time has expired for any 23 person to file a claim to the defendant currency under 18 U.S.C. § 983(a)(2)(A)-(E), and no person 24 other than the claimant has filed a claim to the defendant currency as required by law in the 25 administrative forfeiture proceeding. 26 3. 27 Under 18 U.S.C. § 983(a)(3)(A), the United States is required to file a complaint for

forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant

currency is subject to forfeiture within ninety days after a claim has been filed in the administrative forfeiture proceedings, unless the court extends the deadline for good cause shown or by agreement of the parties. That deadline is September 8, 2014.

- 4. As provided in 18 U.S.C. § 983(a)(3)(A), the parties wish by agreement to further extend to November 7, 2014, the time in which the United States is required to file a civil complaint for forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to forfeiture.
- 6. Accordingly, the parties agree that the deadline by which the United States shall be required to file a complaint for forfeiture against the defendant currency and/or to obtain an indictment alleging that the defendant currency is subject to forfeiture shall be extended to November 7, 2014.
