28 Examination of the above-entitled actions reveals that these actions are related within the meaning of Local Rule 123 (E.D. Cal. 2005). 6 reassigned cases shall be shown as 2:15-cv-00399 JAM-AC.

7           IT IS FURTHER ORDERED that the Clerk of the Court make  
8 appropriate adjustment in the assignment of civil cases to  
9 compensate for this reassignment.
