2 entitled Court upon Plaintiffs' *Ex Parte* Application For an Order Extending Time to File  
3 Oppositions to the Motions For Summary Judgment of Cornerstone Community Bank,

- 18 c. November 24, 2016: Last day for the Plaintiffs to file a reply in support of any  
19 cross motion for summary judgment; and
- 20 d. December 1, 2016: Hearing on the Cornerstone Defendants' Motions for Summary  
21 Judgment and any cross motion by the Plaintiffs.
