 23 The parties hereby stipulate to the following:

- 24 1. The default of Defendants TOWN OF PARADISE and PARADISE POLICE
 25 DEPARTMENT, entered by the Clerk of the Court on April 10, 2015 (ECF Doc. 7), shall be set aside.
 26 2. Plaintiff RICHARD S. MARTIN shall file with the Court a First Amended Complaint on
 27 or before May 1, 2015.
 28 3. The Law Office of Douglas R. Thorn shall accept and waive service of process on behalf

1 of any named Defendants who are employees of Defendants TOWN OF PARADISE or PARADISE
2 POLICE DEPARTMENT named in Plaintiff's First Amended Complaint.

3 4. Defendants named in the First Amended Complaint represented by the Law Office of
4 Douglas R. Thorn shall file with the Court a responsive pleading to Plaintiff's First Amended Complaint
5 on or before May 15, 2015. The status of Defendant PARADISE POLICE DEPARTMENT as a public
6 entity is disputed and reserved for determination in law and motion in the case.
