19	herein, do hereby stipulate and agree that the expert witness disclosure deadline of August 30		
20	2016 be extended to September 30, 2016, and	the supplemental expert disclosure deadline of	
21	September 20, 2016 be extended to October 20, 2016. The basis for the extension is as follows:		
22	1. The parties have stipulated to an I	ndependent Psychiatric Examination of plaintiff

3	3. Therefore, the parties' proposed new expert discovery deadlines do not interfere

5	4. The parties previously sought and obtained by stipulation dated February 12, 2016,	
6	a continuance of the trial date due to the scheduled vacation of defendant STEVE	
7	SCHUAMLEFFEL, along with the extension of other deadlines, including expert discovery. The
