21	§1983 and 28 U.S.C. § 1915A(b) against defendant Anderson. See Cockcroft v. Kirkland, 548 F.		
22	Supp. 2d 767, 774- 775 (N.D. Cal. 2008) (collecting cases on unsanitary prison conditions).		
23	If the allegations of the amended complaint are proven, plaintiff has a reasonable opportunity to		
24	prevail on the merits of this action.		
25	As to the remaining six defendants, the undersigned concludes that the FAC does not cure		
26	the defects of the original complaint as set forth in the May 28, 2015 screening order. <u>See</u>		
27	Daniels-Hall v. National Educ. Ass'n, 629 F.3d 992, 998 (9th Cir. 2010) (while the court must		
28	assume plaintiff's factual allegations are true, it is not required to accept allegations that are
