21 Plaintiffs [REDACTED] M [REDACTED], T [REDACTED] V [REDACTED] and A [REDACTED] V [REDACTED] have filed an ex parte  
 22 application to deposit funds to blocked accounts.

23 Based on the supporting documents and arguments of counsel, the court grants Plaintiffs'  
 24 ex parte application, and ORDERS the following:

- 25 1. The sum of \$14,684.50 shall be deposited into an interest bearing federally insured  
 26 blocked bank account on behalf of [REDACTED] M [REDACTED]. The account shall indicate the  
 27 name of the minor or other person who owns the account. [REDACTED] M [REDACTED]' date of

1 birth is February 25, 2003 and he turns 18 on February 25, 2021. The funds shall  
2 be deposited by either of [REDACTED] M [REDACTED]' guardians, Isabella Maranon or Jorge  
3 Maranon. Upon turning 18, [REDACTED] M [REDACTED] shall be entitled to withdraw any or all  
4 of the funds from the account.

5 2. The sum of \$9,789.66 shall be deposited into an interest bearing federally insured  
6 blocked bank account on behalf of T [REDACTED] V [REDACTED]. The account shall indicate the  
7 name of the minor or other person who owns the account. T [REDACTED] V [REDACTED]'s date of  
8 birth is July 11, 2003 and he turns 18 on July 11, 2021. The funds shall be  
9 deposited by either of T [REDACTED] V [REDACTED]'s guardians, Will or Jackie Valerio. Upon  
10 turning 18, T [REDACTED] V [REDACTED] shall be entitled to withdraw any or all of the funds from  
11 the account.

12 3. The sum of \$9,789.66 shall be deposited into an interest bearing federally insured  
13 blocked bank account on behalf of A [REDACTED] V [REDACTED]. The account shall indicate the  
14 name of the minor or other person who owns the account. A [REDACTED] V [REDACTED]'s date of  
15 birth is September 21, 2001 and she turns 18 on September 21, 2019. The funds  
16 shall be deposited by either of A [REDACTED] V [REDACTED]'s guardians, Will or Jackie Valerio.  
17 Upon turning 18, A [REDACTED] V [REDACTED] shall be entitled to withdraw any or all of the  
18 funds from the account.
