ORDER

28 On April 21, 2016 this Court issued the following order:

“[T]he Court STAYS this action as to the third through sixth causes of
 action. All claims asserted by Plaintiff Howard Jones are stayed pending
 resolution of the state proceeding. As to the tenants, the Court DISMISSES
 WITH LEAVE TO AMEND the first and second causes of action against

1 Defendant City of Sacramento and DENIES the motion to dismiss those two
2 claims against Defendant Armstrong. The Tenant Plaintiffs' amended
3 complaint, if any, must be filed within (20) days of the date of this order.
Defendants' responsive pleading is due within twenty (20) days thereafter."

4 The Tenant Plaintiffs did not file a second amended complaint to address the first and
5 second causes of action against Defendant City of Sacramento, which were dismissed with leave
6 to amend.

7 GOOD CAUSE APPEARING, IT IS HEREBY ORDERED THAT the first and second
8 causes of action in the first amended complaint against Defendant City of Sacramento are
9 dismissed. Defendants' responsive pleading to the first and second causes of action against
10 Defendant Armstrong must be filed within ten (10) days of the date of this order.
