 25 LLC (collectively, "Counterdefendants") and defendant and counterclaimant California
 26 Milk Processor Board ("Counterclaimant"), by and through their respective attorneys of
 27 record, hereby stipulate that: (1) Counterclaimant filed its original counterclaim against
 28 FMMI on May 21, 2015. Before FMMI responded, Counterclaimant filed its First Amended

1 Counterclaim on June 4, 2015, adding, among other things, Jon Tollefson and Reach
2 Companies, Inc. as additional counterdefendants; (2) counterdefendant FMMI was served
3 with the First Amended Counterclaim on June 4, 2015, and counterdefendants Jon
4 Tollefson and Reach Companies, Inc. were served on June 10, 2015; (3) the time for
5 Counterdefendants to respond or otherwise plead to the First Amended Counterclaim
6 shall be extended from June 22, 2015 to July 16, 2015 (a date which is not more than 28
7 days from the initial response date); and (4) this is the first such extension of time to
8 respond.
