23	until an action has been properly commenced. ²

1	In accordance with the above, IT IS HEREBY ORDERED that:	
2	1. Mr. Quintanilla is granted thirty days from the date of service of this order to file a	
3	complaint that complies with the requirements of the Civil Rights Act, the Federal Rules of Civil	
4	Procedure, and the Local Rules of Practice. The complaint must bear the docket number assigned	
5	this case. Mr. Quintanilla shall also submit, within thirty days from the date of this order, the	
6	application to proceed in forma pauperis on the form provided by the Clerk of Court, or the filing	
7	fee in the amount of \$400.00. Mr. Quintanilla's failure to comply with this order will result in	
8	this case being closed.	
9	2. The Clerk of the Court is directed to send Mr. Quintanilla the court's form for filing a	
10	civil rights action, and the application to proceed in forma pauperis by a prisoner.
