**STIPULATION EXTENDING TIME FOR DEFENDANTS

21 On May 9, 2016, the Court issued its Order Granting Motion to Dismiss with Leave to Amend.  
22 (Docket No. 14.)

24 On May 9, 2016, the Court also issued its Minute Order which states, in relevant part, that  
25 "Plaintiff is hereby granted thirty (30) days from the entry of this order to file an Amended Complaint.

1 Defendants Answer shall be due within twenty-one (21) days of the filing of the Amended Complaint.”  
2 (Docket No. 15.)

3 On June 8, 2016, Plaintiff filed her Amended Complaint. (Docket No. 16.)

4 The Eastern District’s Local Rule 144(a) provides, in relevant part, that all extensions of time  
5 (beyond an initial stipulation extending time to respond to the complaint) “must be approved by the  
6 Court.”

7 Pursuant to Local Rule 144(a), the parties, by and through their attorneys of record, hereby  
8 stipulate that the deadline for Defendants MICHAEL J. MACFARLAND and THE PUBLIC GROUP,  
9 LLC, a Utah limited liability company, to file their response to the Amended Complaint whether by  
10 means of an Answer, a Motion under Rule 12 of the Federal Rules of Civil Procedure or other  
11 appropriate motion, will be extended from June 29, 2016 until and including July 22, 2016.


