20	IT IS HEREBY STIPULATED by and between the parties through their		
21	undersigned counsel, subject to the approval of the Court, that Michael Wade Curl		
22	be awarded attorney fees and expenses in the amount of four thousand dollars		
23	(\$4,000.00) under the Equal Access to Justice Act (EAJA), 28 U.S.C. § 2412(d),.		
24	This amount represents compensation for all legal services rendered on behalf of		
25	Plaintiff by counsel in connection with this civil action, in accordance with 28		
	U.S.C. §§ 1920; 2412(d).		

After the Court issues an order for EAJA fees to Michael Wade Curl, the government will consider the matter of Michael Wade Curl's assignment of EAJA fees to Monica Perales. The retainer agreement containing the assignment is attached as exhibit 1. Pursuant to Astrue v. Ratliff, 130 S.Ct. 2521, 2529 (2010), the ability to honor the assignment will depend on whether the fees are subject to any offset allowed under the United States Department of the Treasury's Offset Program. After the order for EAJA fees is entered, the government will determine whether they are subject to any offset.

Fees shall be made payable to Michael Wade Curl, but if the Department of the Treasury determines that Michael Wade Curl does not owe a federal debt, then the government shall cause the payment of fees, expenses and costs to be made directly to Law Offices of Lawrence D. Rohlfing, pursuant to the assignment executed by Michael Wade Curl. Any payments made shall be delivered to Monica Perales.

This stipulation constitutes a compromise settlement of Michael Wade Curl's request for EAJA attorney fees, and does not constitute an admission of liability on the part of Defendant under the EAJA or otherwise. Payment of the agreed amount shall constitute a complete release from, and bar to, any and all claims that Michael Wade Curl and/or Monica Perales including Law Offices of Lawrence D. Rohlfing may have relating to EAJA attorney fees in connection with this action.
