However, federal courts in California traditionally have chosen to hear petitions challenging a conviction or sentence in the district of conviction. See <u>Dannenberg v. Ingle</u>, 831 F. Supp. 767, 767 (N.D. Cal. 1993); <u>Laue v. Nelson</u>, 279 F. Supp. 265, 266 (N.D. Cal. 1968). The petition indicates that Petitioner was convicted in Sacramento County which lies within the venue of the Eastern District of California. See 28 U.S.C. 84(b).
