18	An initial scheduling conference was held in this case on May 11, 2017. Mary	
19	Melton appeared for plaintiff; Cris Vaughan appeared for defendants.	
20	Having reviewed the parties' Joint Status Report filed on April 26, 2017, and	
21	discussed a schedule for the case with counsel at the hearing, the court makes the following	
22	orders:	
23	I. <u>SERVICE OF PROCESS</u>	
24	All named defendants have been served and no further service is permitted without	
25	leave of court, good cause having been shown.	
26	A Clerk's Entry of Default was entered on September 28, 2016 as to defendant Rai	
27	Rocklin Investments, LLC. Plaintiff shall promptly file its motion for default judgment as to	
28	defendant Rai Rocklin Investments, LLC in a	accordance with the Local Rules.

2	II. <u>ADDITIONAL PARTIES/AMENDMENTS/PLEADINGS</u>		
3	No further joinder of parties or amendments to pleadings is permitted without		
4	leave of court, good cause having been shown. See Fed. R. Civ. P. 16(b); Johnson v. Mammoth		
5	Recreations, Inc., 975 F.2d 604 (9th Cir. 1992).		
6	III. JURISDICTION/VENUE		
7	Jurisdiction is predicated upon 28 U.S.C. §§ 1331 and 1343(a)(3) and (a)(4).		
8	Jurisdiction and venue are not disputed.		
9	IV. <u>EARLY DEFENSE MOTION</u>		
10	Defendants plan to file a motion challenging plaintiff's request for injunctive relief		
11	as moot. Any such motion shall be filed with the court within thirty (30) days of the scheduling		
12	conference.		
13	V. <u>DISCOVERY</u>		
14	Initial disclosures as required by Federal Rule of Civil Procedure 26(a) have been		
15	completed. All discovery shall be completed by February 26, 2018. In this context,		
16	"completed" means that all discovery shall have been conducted so that all depositions have been		
17	taken and any disputes relative to discovery shall have been resolved by appropriate order if		
18	necessary and, where discovery has been ordered, the order has been obeyed. All motions to		
19	compel discovery must be noticed on the magistrate judge's calendar in accordance with the local		
20	rules of this court. While the assigned magistrate judge reviews proposed discovery phase		
21	protective orders, requests to seal or redact are decided by Judge Mueller as discussed in more		
22	detail below. In addition, while the assigned magistrate judge handles discovery motions, the		
23	magistrate judge cannot change the schedule set in this order, except that the magistrate judge		
24	may modify a discovery cutoff to the extent such modification does not have the effect of		
25	requiring a change to the balance of the schedule.		
26	VI. <u>DISCLOSURE OF EXPERT WITNESSES</u>		
27	All counsel are to designate in writing, file with the court, and serve upon all other		
28	parties the name, address, and area of expertise of each expert that they propose to tender at trial 2		

1 not later than **March 16, 2018**. The designation shall be accompanied by a written report 2 prepared and signed by the witness. The report shall comply with Fed. R. Civ. P. 26(a)(2)(B). 3 By April 6, 2018, any party who previously disclosed expert witnesses may submit a 4 supplemental list of expert witnesses who will express an opinion on a subject covered by an 5 expert designated by an adverse party, if the party supplementing an expert witness designation 6 has not previously retained an expert to testify on that subject. The supplemental designation 7 shall be accompanied by a written report, which shall also comply with the conditions stated 8 above.

Failure of a party to comply with the disclosure schedule as set forth above in all
likelihood will preclude that party from calling the expert witness at the time of trial. An expert
witness not appearing on the designation will not be permitted to testify unless the party offering
the witness demonstrates: (a) that the necessity for the witness could not have been reasonably
anticipated at the time the list was proffered; (b) that the court and opposing counsel were
promptly notified upon discovery of the witness; and (c) that the witness was promptly made
available for deposition.

16 For purposes of this scheduling order, an "expert" is any person who may be used 17 at trial to present evidence under Rules 702, 703 and 705 of the Federal Rules of Evidence, which 18 include both "percipient experts" (persons who, because of their expertise, have rendered expert 19 opinions in the normal course of their work duties or observations pertinent to the issues in the 20 case) and "retained experts" (persons specifically designated by a party to be a testifying expert 21 for the purposes of litigation). A party shall identify whether a disclosed expert is percipient, 22 retained, or both. It will be assumed that a party designating a retained expert has acquired the 23 express permission of the witness to be so listed. Parties designating percipient experts must state 24 in the designation who is responsible for arranging the deposition of such persons.

All experts designated are to be fully prepared at the time of designation to render an informed opinion, and give the bases for their opinion, so that they will be able to give full and complete testimony at any deposition taken by the opposing party. Experts will not be permitted /////

1 to testify at trial as to any information gathered or evaluated, or opinion formed, after deposition 2 taken subsequent to designation. All expert discovery shall be completed by May 4, 2018. MOTION HEARING SCHEDULE 3 VII. 4 All dispositive motions, except motions for continuances, temporary restraining orders or other emergency applications, shall be heard no later than **June 1, 2018.**<sup>1</sup> The parties 5 6 may obtain available hearing dates by checking Judge Mueller's page on the court's website. 7 All purely legal issues are to be resolved by timely pretrial motions. Local Rule 8 230 governs the calendaring and procedures of civil motions; the following provisions also apply: 9 The opposition and reply must be filed by 4:00 p.m. on the day due; and (a) 10 (b) When the last day for filing an opposition brief falls on a legal holiday, the 11 opposition brief shall be filed on the last court day immediately preceding the legal holiday. 12 Failure to comply with Local Rule 230(c), as modified by this order, may be deemed consent to 13 the motion and the court may dispose of the motion summarily. Brydges v. Lewis, 18 F.3d 651, 14 652-53 (9th Cir. 1994). 15 The court values the importance of training young attorneys. The parties are 16 encouraged to consider assigning oral argument to a young attorney. If a written request for oral 17 argument is filed before a hearing, stating an attorney of four or fewer years out of law school 18 will argue the oral argument, then the court will ordinarily hold the hearing, although the court's 19 schedule and calendar may require the hearing to be reset. Otherwise, the court may find it 20 appropriate in some actions to submit a motion without oral argument. 21 The court places a page limit of twenty (20) pages on all moving papers, twenty 22 (20) pages on oppositions, and ten (10) pages for replies. All requests for page limit increases 23 must be made in writing at least fourteen (14) days prior to the filing of the motion. 24 Prior to filing a motion in a case in which the parties are represented by counsel, 25 counsel shall engage in a pre-filing meet and confer to discuss thoroughly the substance of the 26 contemplated motion and any potential resolution. Plaintiff's counsel should carefully evaluate 27 Note that this date may not correspond to a law and motion calendar date. 28

1 the defendant's contentions as to deficiencies in the complaint and in many instances the party 2 considering a motion should agree to any amendment that would cure a curable defect. Counsel 3 should discuss the issues sufficiently so that if a motion of any kind is filed, including for 4 summary judgment, the briefing is directed only to those substantive issues requiring resolution 5 by the court. Counsel should resolve minor procedural or other non-substantive matters during 6 the meet and confer. A notice of motion shall contain a certification by counsel filing the 7 motion that meet and confer efforts have been exhausted, with a brief summary of meet and 8 confer efforts.

9 <u>The parties are cautioned that failure to raise a dispositive legal issue that could</u>
10 <u>have been tendered to the court by proper pretrial motion prior to the dispositive motion cut-off</u>
11 <u>date may constitute waiver of such issue</u>.

12 VIII. <u>SEALING</u>

13 No document will be sealed, nor shall a redacted document be filed, without the 14 prior approval of the court. If a document for which sealing or redaction is sought relates to the 15 record on a motion to be decided by Judge Mueller, the request to seal or redact should be 16 directed to her and not the assigned Magistrate Judge. All requests to seal or redact shall be 17 governed by Local Rules 141 (sealing) and 140 (redaction); protective orders covering the 18 discovery phase of litigation shall not govern the filing of sealed or redacted documents on the 19 public docket. The court will only consider requests to seal or redact filed by the proponent of 20 sealing or redaction. If a party plans to make a filing that includes material an opposing party has 21 identified as confidential and potentially subject to sealing, the filing party shall provide the 22 opposing party with sufficient notice in advance of filing to allow for the seeking of an order of 23 sealing or redaction from the court.

24 IX. <u>FINAL PRETRIAL CONFERENCE</u>

The Final Pretrial Conference is set for September 21, 2018, at 10:00 a.m. At
least one of the attorneys who will conduct the trial for each of the parties shall attend the Final
Pretrial Conference. If by reason of illness or other unavoidable circumstance a trial attorney is

1 unable to attend, the attorney who attends in place of the trial attorney shall have equal familiarity 2 with the case and equal authorization to make commitments on behalf of the client. 3 Counsel for all parties are to be fully prepared for trial at the time of the Final 4 Pretrial Conference, with no matters remaining to be accomplished except production of 5 witnesses for oral testimony. The parties shall confer and file a joint pretrial conference 6 statement by August 31, 2018. The provisions of Local Rule 281 shall apply with respect to the 7 matters to be included in the joint pretrial statement. In addition to those subjects listed in Local 8 Rule 281(b), the parties are to provide the court with the following: 9 - A plain, concise statement that identifies every non-discovery motion previously 10 tendered to the court and its resolution. 11 - A concise, joint list of undisputed core facts that are relevant to each claim. 12 Disputed core facts should then be identified in the same manner. The parties are reminded not to 13 identify every fact in dispute but only those disputed facts that are essential to the formulation of 14 each claim. Each disputed fact and undisputed fact should be separately numbered or lettered. 15 Where the parties are unable to agree on the core disputed facts, they should nevertheless list core 16 disputed facts in the above manner. 17 - Concise lists of disputed evidentiary issues that will be the subject of a party's 18 motion *in limine*, and whether the parties believe resolution of any of these motions will be 19 necessary before the first day of trial. 20 - Each party's points of law, which concisely describe the legal basis or theory 21 underlying their claims and defenses. Points of law should reflect issues derived from the core 22 undisputed and disputed facts. Parties shall not include argument with any point of law; the 23 parties may include concise arguments in their trial briefs. 24 - A joint statement of the case in plain concise language, which will be read to the 25 jury during voir dire and at the beginning of the trial. The purpose of the joint statement is to 26 inform the jury what the case is about. 27 - The parties' position on the number of jurors to be impaneled to try the case. 28 ///// 6

Discovery documents to be listed in the pretrial statement shall not include 2 documents to be used only for impeachment and in rebuttal.

3 The parties are reminded that pursuant to Local Rule 281 they are required to 4 attach to the Final Pretrial Conference Statement an exhibit listing witnesses and exhibits they 5 propose to offer at trial. After the name of each witness, each party shall provide a brief 6 statement of the nature of the testimony to be proffered. The parties may file a joint list or each 7 party may file separate lists. These list(s) shall not be contained in the body of the Final Pretrial 8 Conference Statement itself, but shall be attached as separate documents to be used as addenda to 9 the Final Pretrial Order.

10 Plaintiff's exhibits shall be listed numerically. Defendant's exhibits shall be listed 11 alphabetically. The parties shall use the standard exhibit stickers provided by the court: pink for 12 plaintiff and blue for defendant. In the event that the alphabet is exhausted, the exhibits shall be 13 marked "AA-ZZ". However, if the amount of defendant exhibits exceeds "ZZ" exhibits shall be 14 then listed as AAA, BBB, CCC etc. All multi-page exhibits shall be stapled or otherwise fastened 15 together and each page within the exhibit shall be numbered. The list of exhibits shall not include 16 excerpts of depositions to be used only for impeachment. In the event that plaintiff(s) and 17 defendant(s) offer the same exhibit during trial, that exhibit shall be referred to by the designation 18 the exhibit is first identified. The court cautions the parties to pay attention to this detail so that 19 all concerned, including the jury, will not be confused by one exhibit being identified with both a 20 number and a letter. The parties are encouraged to consult concerning exhibits and, to the extent 21 possible, provide joint exhibits, which shall be designated as JX and listed numerically, e.g., JX-22 1, JX-2.

The Final Pretrial Order will contain a stringent standard for the offering at trial of 24 witnesses and exhibits not listed in the Final Pretrial Order, and the parties are cautioned that the 25 standard will be strictly applied. On the other hand, the listing of exhibits or witnesses that a 26 party does not intend to offer will be viewed as an abuse of the court's processes.

27 Counsel shall produce all trial exhibits to Casey Schultz, the Courtroom Deputy, 28 no later than 3:00 p.m. on the Friday before trial.

Failure to comply with Local Rule 281, as modified by this order, may be grounds
 for sanctions.

3	The parties also are reminded that pursuant to Rule 16 of the Federal Rules of		
4	Civil Procedure it will be their duty at the Final Pretrial Conference to aid the court in: (a) the		
5	formulation and simplification of issues and the elimination of frivolous claims or defenses; (b)		
6	the settling of facts that should properly be admitted; and (c) the avoidance of unnecessary proof		
7	and cumulative evidence. Counsel must cooperatively prepare the joint Final Pretrial Conference		
8	Statement and participate in good faith at the Final Pretrial Conference with these aims in mind. <sup>2</sup>		
9	A failure to do so may result in the imposition of sanctions which may include monetary		
10	sanctions, orders precluding proof, elimination of claims or defenses, or such other sanctions as		
11	the court deems appropriate.		
12	Concurrently with the filing of the Joint Final Pretrial Conference Statement,		
13	counsel shall submit to chambers the word processable version of the Statement, in its entirety		
14	(including the witness and exhibit lists) to: kjmorders@caed.uscourts.gov.		
15	X. MOTIONS IN LIMINE		
16	All motions in limine must be filed in conjunction with the joint pretrial statement.		
17	In most cases, motions in limine are addressed and resolved on the morning of the first day of		
18	trial. As noted above, the parties may alert the court at the final pretrial conference and in their		
19	final pretrial statement that a particular motion or motions should be resolved earlier. At the final		
20	pretrial conference, the court will then set a briefing and hearing schedule on these motions in		
21	limine as necessary.		
22	The parties are reminded that a motion <i>in limine</i> is a pretrial procedural device		
23	designed to address the admissibility of evidence. The court looks with disfavor upon		
24	dispositional motions presented at the Final Pretrial Conference or at trial in the guise of motions		
25	in limine.		
26	$\frac{1}{2}$ "If the pretrial conference discloses that no material facts are in dispute and that the undisputed		
27	facts entitle one of the parties to judgment as a matter of law," the court may summarily dispose		

<sup>facts entitle one of the parties to judgment as a matter of law," the court may summarily dispose of the case or claims.</sup> *Portsmouth Square v. Shareholders Protective Comm.*, 770 F.2d 866, 86869 (9th Cir. 1985).

## 1 XI. TRIAL SETTING 2 The jury trial is set for October 29, 2018 at 9:00 a.m. The parties estimate a trial 3 length of approximately two (2) to three (3) days. Trial briefs are due by October 15, 2018. 4 XII. SETTLEMENT CONFERENCE 5 No settlement conference is currently scheduled. A settlement conference may be 6 set at the time of the Final Pretrial Conference or at an earlier time at the parties' request. In the 7 event that an earlier court settlement conference date or referral to the Voluntary Dispute 8 Resolution Program (VDRP) is requested, the parties shall file said request jointly, in writing. 9 Because the case will be tried to a jury, all parties should be prepared to advise the court whether 10 they will stipulate to the trial judge acting as settlement judge and waive disqualification by virtue 11 thereof. 12 Counsel are instructed to have a principal with full settlement authority present at 13 any Settlement Conference or to be fully authorized to settle the matter on any terms. Each judge 14 has different requirements for the submission of settlement conference statements; the appropriate 15 instructions will be sent to you after the settlement judge is assigned. 16 MODIFICATION OF STATUS (PRETRIAL SCHEDULING) ORDER XIII. 17 The parties are reminded that pursuant to Rule 16(b) of the Federal Rules of Civil 18 Procedure, the Status (Pretrial Scheduling) Order shall not be modified except by leave of court 19 upon a showing of good cause. Agreement of the parties by stipulation alone does not constitute 20 good cause. Except in extraordinary circumstances, unavailability of witnesses or counsel does 21 not constitute good cause. 22 As noted, the assigned magistrate judge is authorized to modify only the discovery 23 dates shown above to the extent any such modification does not impact the balance of the 24 schedule of the case. 25 ///// 26 ///// 27 ///// 28 ///// 9
