#### PURPOSES AND LIMITATIONS

Disclosure and discovery activity in this action are likely to involve production of confidential, 2 proprietary, or private information for which special protection from public disclosure and from use 3 for any purpose other than prosecuting this litigation may be warranted. Accordingly, the parties 4 hereby stipulate to and petition the court to enter the following Stipulated Protective Order. The 5 parties acknowledge that this Order does not confer blanket protections on all disclosures or responses 6 to discovery and that the protection it affords from public disclosure and use extends only to the 7 limited information or items that are entitled to confidential treatment under the applicable legal 8 principles. The parties further acknowledge, as set forth in Section 12.3, below, that this Stipulated 9 Protective Order does not entitle them to file confidential information under seal; Civil Local Rule 10 141 sets forth the procedures that must be followed and the standards that will be applied when a party 11 seeks permission from the court to file material under seal.

#### DEFINITIONS

13 2.1 Challenging Party: a Party or Non-Party that challenges the designation of information or 14 items under this Order.

15 2.2 "CONFIDENTIAL" Information or Items: information (regardless of how it is generated, 16 stored or maintained) or tangible things that qualify for protection under Federal Rule of Civil 17 Procedure 26(c), and for which public disclosure is likely to result in particularized harm and violate 18 privacy interests recognized by law. This information may include:

5 Disclosure or Discovery Material: all items or information, regardless of the medium or

2.10 Party: any party to this action, including all of its officers, directors, employees, consultants,

3. **SCOPE**

4 The protections conferred by this Stipulation and Order cover not only Protected Material (as 5 defined above), but also (1) any information copied from Protected Material; (2) all copies, excerpts, summaries, or compilations of Protected Material that reveal the source of the Protected Material or 6 7 that reveal specific information entitled to confidentiality as a matter of law; and (3) any testimony, conversations, or presentations by Parties or their Counsel that might reveal Protected Material. 8 However, the protections conferred by this Stipulation and Order do not cover the following 9 information: (a) any information that is in the public domain at the time of disclosure to a Receiving 10 Party or becomes part of the public domain after its disclosure to a Receiving Party as a result of 11 publication not involving a violation of this Order, including becoming part of the public record 12 through trial or otherwise; and (b) any information known to the Receiving Party prior to the 13 disclosure or obtained by the Receiving Party after the disclosure from a source who obtained the 14 information lawfully and under no obligation of confidentiality to the Designating Party. Any use of 15 Protected Material at trial shall be governed by a separate agreement or order.

## **DURATION**

Even after final disposition of this litigation, the confidentiality obligations imposed by this Order shall remain in effect until a Designating Party agrees otherwise in writing or a court order otherwise directs. Final disposition shall be deemed to be the later of (1) dismissal of all claims and 20 defenses in this action, with or without prejudice; and (2) final judgment herein after the completion and exhaustion of all appeals, rehearings, remands, trials, or reviews of this action, including the time limits for filing any motions or applications for extension of time pursuant to applicable law.

## DESIGNATING PROTECTED MATERIAL

24 5.1 Exercise of Restraint and Care in Designating Material for Protection. Each Party or Non-Party 25 that designates information or items for protection under this Order must take care to limit any such 26 designation to specific material that qualifies under the appropriate standards. The Designating Party 27 must designate for protection only those parts of material, documents, items, or oral or written

communications that qualify – so that other portions of the material, documents, items, or

communications for which protection is not warranted are not swept unjustifiably within the ambit of
this Order.

Mass, indiscriminate, or routinized designations are prohibited. Designations that are shown to
be clearly unjustified or that have been made for an improper purpose (e.g., to unnecessarily encumber
or retard the case development process or to impose unnecessary expenses and burdens on other
parties) expose the Designating Party to sanctions.

8 If it comes to a Designating Party's attention that information or items that it designated for
9 protection do not qualify for protection, that Designating Party must promptly notify all other Parties
10 that it is withdrawing the mistaken designation.

5.2 <u>Manner and Timing of Designations</u>. Except as otherwise provided in this Order (see, e.g.,
 second paragraph of section 5.2(a) below), or as otherwise stipulated or ordered, Disclosure or
 Discovery Material that qualifies for protection under this Order must be clearly so designated before
 the material is disclosed or produced.

Designation in conformity with this Order requires:

(a) for information in documentary form (e.g., paper or electronic documents, but excluding 16 transcripts of depositions or other pretrial or trial proceedings), that the Producing Party affix the 17 legend "CONFIDENTIAL" to each page that contains protected material. If only a portion or portions 18 of the material on a page qualifies for protection, the Producing Party also must clearly identify the 19 protected portion(s) (e.g., by making appropriate markings in the margins). A Party or Non-Party that 20 makes original documents or materials available for inspection need not designate them for protection 21 until after the inspecting Party has indicated which material it would like copied and produced. During 22 the inspection and before the designation, all of the material made available for inspection shall be 23 deemed "CONFIDENTIAL." After the inspecting Party has identified the documents it wants copied 24 and produced, the Producing Party must determine which documents, or portions thereof, qualify for 25 protection under this Order. Then, before producing the specified documents, the Producing Party 26 must affix the "CONFIDENTIAL" legend to each page that contains Protected Material. If only a

1 portion or portions of the material on a page qualifies for protection, the Producing Party also must 2 clearly identify the protected portion(s) (e.g., by making appropriate markings in the margins). 3 (b) for testimony given in deposition or in other pretrial or trial proceedings, that the Designating 4 Party identify on the record, before the close of the deposition, hearing, or other proceeding, all 5 protected testimony. (c) for information produced in some form other than documentary and for any other tangible items, 6 7 that the Producing Party affix in a prominent place on the exterior of the container or containers in which the information or item is stored the legend "CONFIDENTIAL." If only a portion or portions 8 of the information or item warrant protection, the Producing Party, to the extent practicable, shall 9 identify the protected portion(s). 10 5.3 Inadvertent Failures to Designate. If timely corrected, an inadvertent failure to designate 11 qualified information or items does not, standing alone, waive the Designating Party's right to secure 12 protection under this Order for such material. Upon timely correction of a designation, the Receiving 13 Party must make reasonable efforts to assure that the material is treated in accordance with the 14 provisions of this Order. 15 6. CHALLENGING CONFIDENTIALITY DESIGNATIONS 16 6.1 Timing of Challenges. Any Party or Non-Party may challenge a designation of confidentiality 17 at any time. Unless a prompt challenge to a Designating Party's confidentiality designation is 18 necessary to avoid foreseeable, substantial unfairness, unnecessary economic burdens, or a significant 19 disruption or delay of the litigation, a Party does not waive its right to challenge a confidentiality 20 designation by electing not to mount a challenge promptly after the original designation is disclosed. 21 6.2 Meet and Confer. The Challenging Party shall initiate the dispute resolution process by 22 providing written notice of each designation it is challenging and describing the basis for each 23 challenge. To avoid ambiguity as to whether a challenge has been made, the written notice must recite 24 that the challenge to confidentiality is being made in accordance with this specific paragraph of the 25 Protective Order. The parties shall attempt to resolve each challenge in good faith and must begin the 26 process by conferring directly (in voice to voice dialogue; other forms of communication are not 27 sufficient) within 14 days of the date of service of notice. In conferring, the Challenging Party must 28

explain the basis for its belief that the confidentiality designation was not proper and must give the
Designating Party an opportunity to review the designated material, to reconsider the circumstances,
and, if no change in designation is offered, to explain the basis for the chosen designation. A
Challenging Party may proceed to the next stage of the challenge process only if it has engaged in this
meet and confer process first or establishes that the Designating Party is unwilling to participate in the
meet and confer process in a timely manner.

7 6.3 Judicial Intervention. If the Parties cannot resolve a challenge without court intervention, the Designating Party shall file and serve a motion to retain confidentiality under Civil 8 Local Rule 230 (and in compliance with Civil Local Rule 141, if applicable) within 21 days of the 9 initial notice of challenge or within 14 days of the parties agreeing that the meet and confer process 10 will not resolve their dispute, whichever is earlier. Each such motion must be accompanied by a 11 competent declaration affirming that the movant has complied with the meet and confer requirements 12 imposed in the preceding paragraph. Failure by the Designating Party to make such a motion 13 including the required declaration within 21 days (or 14 days, if applicable) shall automatically waive 14 the confidentiality designation for each challenged designation. In addition, the Challenging Party 15 may file a motion challenging a confidentiality designation at any time if there is good cause for doing 16 so, including a challenge to the designation of a deposition transcript or any portions thereof. Any 17 motion brought pursuant to this provision must be accompanied by a competent declaration affirming 18 that the movant has complied with the meet and confer requirements imposed by the preceding 19 paragraph.

The burden of persuasion in any such challenge proceeding shall be on the Designating Party. Frivolous challenges, and those made for an improper purpose (e.g., to harass or impose unnecessary expenses and burdens on other parties) may expose the Challenging Party to sanctions. Unless the Designating Party has waived the confidentiality designation by failing to file a motion to retain confidentiality as described above, all parties shall continue to afford the material in question the level of protection to which it is entitled under the Producing Party's designation until the court rules on the challenge.

# ACCESS TO AND USE OF PROTECTED MATERIAL

2	7.1 <u>Basic Principles</u> . A Receiving Party may use Protected Material that is disclosed or produced
3	by another Party or by a Non-Party in connection with this case only for prosecuting, defending, or
4	attempting to settle this litigation. Such Protected Material may be disclosed only to the categories of

## UNAUTHORIZED DISCLOSURE OF PROTECTED MATERIAL

If a Receiving Party learns that, by inadvertence or otherwise, it has disclosed Protected Material to
any person or in any circumstance not authorized under this Stipulated Protective Order, the
Receiving Party must immediately (a) notify in writing the Designating Party of the unauthorized
disclosures, (b) use its best efforts to retrieve all unauthorized copies of the Protected Material, (c)
inform the person or persons to whom unauthorized disclosures were made of all the terms of this
Order, and (d) request such person or persons to execute the "Acknowledgment and Agreement to Be
Bound" that is attached hereto as Exhibit A.

## 11. <u>INADVERTENT PRODUCTION OF PRIVILEGED OR OTHERWISE PROTECTED</u> MATERIAL

When a Producing Party gives notice to Receiving Parties that certain inadvertently produced material
is subject to a claim of privilege or other protection, the obligations of the Receiving Parties are those

set forth in Federal Rule of Civil Procedure 26(b)(5)(B). This provision is not intended to modify
whatever procedure may be established in an e-discovery order that provides for production without
prior privilege review. Pursuant to Federal Rule of Evidence 502(d) and (e), insofar as the parties
reach an agreement on the effect of disclosure of a communication or information covered by the
attorney-client privilege or work product protection, the parties may incorporate their agreement in the
stipulated protective order submitted to the court.

### MISCELLANEOUS

8 12.1 Right to Further Relief. Nothing in this Order abridges the right of any person to seek its
9 modification by the court in the future.

12.2 Right to Assert Other Objections. By stipulating to the entry of this Protective Order no Party 10 waives any right it otherwise would have to object to disclosing or producing any information or item 11 on any ground not addressed in this Stipulated Protective Order. Similarly, no Party waives any right 12 to object on any ground to use in evidence of any of the material covered by this Protective Order. 13 12.3 Filing Protected Material. Without written permission from the Designating Party or a court 14 order secured after appropriate notice to all interested persons, a Party may not file in the public 15 record in this action any Protected Material. A Party that seeks to file under seal any Protected 16 Material must comply with Civil Local Rule 141. Protected Material may only be filed under seal 17 pursuant to a court order authorizing the sealing of the specific Protected Material at issue. Pursuant to 18 Civil Local Rule 141, a sealing order will issue only upon a request establishing that the Protected 19 Material at issue is privileged, protectable as a trade secret, or otherwise entitled to protection under 20 the law. If a Receiving Party's request to file Protected Material under seal pursuant to Civil Local 21 Rule 141(b) is denied by the court, then the Receiving Party may file the information in the public 22 record pursuant to Civil Local Rule 141(e)(1) unless otherwise instructed by the court.
