STIPULATION AND ORDER TO EXTEND TIME  
TO FILE JOINT STATUS REPORT

23 Pursuant to the Court's Order Requiring Joint Status Report dated February 10, 2016 (Dkt. 2),  
24 the parties are required to file a joint status report within sixty (60) days of service of the complaint on a  
25 party. The U.S. Attorney's Office was served with the complaint on June 17, 2016, making the joint  
26 status report due on August 16, 2016. However, because federal officials are defendants in this action  
27 and because the parties stipulated pursuant to Local Rule 144(a) to extend the response deadline, the  
28 defendants' response to the complaint is currently due on September 13, 2016. Defendants anticipate

1 filing a motion to dismiss, which is most likely to be heard by the Court during the third week of  
2 October.

3 Under these circumstances, the parties respectfully suggest that it will be most efficient to extend  
4 the time to file the joint status report and complete the Rule 26(f) conference to a date after the  
5 defendants respond to the complaint and the Court has an opportunity to rule upon any motion to  
6 dismiss that may be filed.

7 Accordingly, the parties hereby stipulate and respectfully request that the Court enter an order  
8 extending the time for the parties to file the joint status report and complete the Rule 26(f) conference  
9 until November 23, 2016.


